



## February 13 - 19 Alert on Immigration

### What's Happening?

Washington district court granted a temporary restraining order against the implementation of the EO nationwide that temporarily bars government officials from enforcing the Muslim ban and the refugee ban in the country, including actions that “prioritize refugee claims of certain religious minorities.” Judge Robart found that the EO adversely affects the residents of states in areas of “employment, education, business, family relations, and freedom to travel.” Judge Robart based the application of the restraining order on a nationwide basis on the ruling of a Texas court in 2015 which enjoined President Obama’s DACA/DAPA executive orders on a nationwide basis.

There have been numerous reports of Immigration and Customs Enforcement (“ICE”) arresting people across the United States. Specifically, we have heard reports of ICE activity in the following cities: Austin and surrounding suburbs, Phoenix, Los Angeles, Atlanta, Chicago, New York, and Portland, etc. from **NILC**

It nullifies the effect of the executive order banning refugees and people from Muslim-majority countries. Trump's order is based on fear-mongering, bigotry and xenophobia that I reject. Support efforts to protect the human rights of people in our community and around the world, including the rights to freedom of religion and non-discrimination. Thank you.*
