**NATIONAL LEVEL - SIMN asks that you contact your Senators (202-224-3121) and Reps (202-225-3121). Ask them to oppose legislation which would remove protections from unaccompanied alien minors who arrive at US borders.**

It would also: *dramatically* cut legal immigration, slashing the ability of US citizens to sponsor family members and eliminating the diversity visa category altogether. Reject this bill.
