



## March 14... Alert on Immigration

### **What's Happening?**

On Feb. 11, Senate Minority Leader Harry Reid introduced the "Fair Day in Court for Kids" Act (S.2540), co-sponsored by Sens. Richard Durbin, Patty Murray, Patrick Leahy, and Robert Menendez, mandating government-appointed counsel for children in immigration court who had crossed the border alone or are victims of other duress such as abuse, torture or violence. Recently the IL Legislative Latino Caucus members held a media conference to discuss the increasing budget crisis for IL families, students, workers and nonprofit organizations in the Latino community. These members called for immediate action to negotiate a balanced budget. The Latino community has been one of the most negatively impacted by the budget impasse in education, human services and immigrant integration. A recent study from the Alternative Schools Network indicated that 85% of Latino/a youth, 18-24, are not in school or at work. Recent immigrant raids have added to the crisis and increased uncertainty among low income Latino families throughout the state. Since July 1, 2015 the state has not been providing immigration services. Latinos are the largest growing segment of the population in IL. It is obvious that this current crisis has profoundly negative implications for the future of Illinois. (Adapted from Project IRENE)

### \*REFUGEE ALERT\*

On March 15, the Syrian War reaches the 5-year mark. Currently, 60 million people are displaced around the world, the largest number since World War II. Historically, the US has recognized its moral and legal imperative to lead by example in addressing global issues such as refugee resettlement. That is why our nation is the largest resettlement country in the world, taking in almost 70% of all refugees resettled by the UNHCR globally last year. Last year, the Obama Administration announced an increase in refugee admissions, from 70,000 last fiscal year, to 85,000 in FY2016 and 100,000 in FY2017. In order to meet the needs of refugee assistance and resettlement programs, we must ensure that adequate funding is provided to local communities to help refugees integrate and thrive.
